

1. PURPOSE

This Cookie Policy has been prepared to inform users about the types of cookies used, their purposes, legal grounds, and users' rights regarding cookies used during visits to the website <https://www.isgold.com/>, operated by İSGOLD Gold Refinery Inc. ("İSGOLD").

2. INFORMATION WHAT IS COOKIE?

Cookies are small text files placed on users' devices (computer, tablet, smartphone, etc.) by the websites they visit. Cookies enable the website to function properly, improve user experience, and allow analysis of website usage.

3. PURPOSES OF USING COOKIES

Cookies are used on the İSGOLD website for the following purposes:

- Ensuring the secure and proper operation of the website
- Remembering user preferences and personalizing the website experience
- Measuring and improving website performance
- Enhancing user experience
- Conducting marketing, advertising, and promotional activities upon obtaining explicit consent

4. TYPES OF COOKIES USED

4.1 Strictly Necessary Cookies

These cookies are essential for the basic functions of the website to operate properly. The website cannot function correctly without these cookies.

4.2 Functional Cookies

These cookies enable a more enhanced and personalized experience by remembering user preferences such as language or region.

4.3 Performance / Analytical Cookies

These cookies collect statistical data regarding website usage. They are used to measure and improve website performance.

4.4 Marketing / Advertising Cookies

These cookies are used to provide users with advertisements and content tailored to their interests.

5. LEGAL GROUNDS FOR PROCESSING COOKIES

Strictly necessary cookies are processed based on the legitimate interests of the data controller in accordance with Article 5/2(f) of the Law No. 6698 on the Protection of Personal Data ("KVKK"). Non-essential cookies (functional, analytical, and marketing cookies) are processed solely based on users' explicit consent.

6. MANAGEMENT OF COOKIES AND CONSENT

Users may manage their cookie preferences through the cookie management panel available on our website and may change or withdraw their explicit consent regarding non-essential cookies at any time. Furthermore, certain cookies used on our website are enabled solely based on your explicit consent, and no data is processed through such cookies unless consent is obtained.

Users may control or delete cookies via their browser settings. However, disabling strictly necessary cookies may result in certain website features not functioning properly.

7. TRANSFER OF PERSONAL DATA AND RIGHTS OF DATA SUBJECTS

Personal data obtained through cookies may be transferred to third parties from whom services are obtained, limited to the purposes specified in this Policy and in compliance with applicable legislation, where necessary. Users may submit their requests regarding their rights under Article 11 of the KVKK through the application methods specified in ISGOLD's Personal Data Protection and Processing Policy.
